### **Water Rates**

On June 9, 2015 the Board approved and adopted a resolution to increase water rates per Table 1 on the back side of this newsletter. The Board put a temporary hold on changes to the tier rates and tier levels. The Board also decided that the new Capital Recovery Charge will start at \$10 per month. The Base Rate increases from \$58 to \$70 per month. The Supplemental Rate increases from \$14 to \$17 per month. In summary your water bill will be increased by \$12 base rate plus \$10 capital recovery charge for an increase of \$22/month for fixed monthly charges. These new rates are effective July 1, 2015.

#### Mail Ballot Election for Board Members

## Water Conservation

Small Water suppliers (those with fewer than 3,000 service connections) such as RNVWD are required to either limit outside irrigation to no more than two times per week or to institute measures that achieve a 25% reduction in use over their 2013 water use. The Board approved Resolution 2014-23, which limits irrigation to two times per week. Small suppliers are now directed to provide a one-time report to the State Water Board, by December 15, 2015 addressing at a minimum; Potable water production from June-November 2013 compared to June-November 2015; The number of days per week outdoor irrigation is allowed and other restrictions implemented to achieve a 25% water use reduction. Thanks to all customers that have already conserved water.

#### All Californians are now prohibited from:

- Washing down sidewalks and driveways;
- Watering outdoor landscapes in a manner that causes excess runoff;
- Washing a motor vehicle with a hose, unless the hose is fitted with a shut-off nozzle;
- Operating a fountain or decorative water feature, unless the water is part of a recirculating system; and
- Irrigating turf or ornamental landscapes during and 48 hours following measurable precipitation.
