WHEREAS, said Rules and Regulations address the payment and financing of assessments, conditions of receiving water service, and water rates and charges; and


WHEREAS, Section 5.8 is amended to add Section 5.8.5 authorizing the District to sell and transfer two District owned regular water service connections; and

NOW, THEREFORE BE IT RESOLVED AND ORDERED, that the District Board of Directors of the Rural North Vacaville Water District does hereby adopt the resolution authorizing amending the District's Rules and Regulations to add Section 5.8.5 authorizing the sale and transfer of the two District owned regular water service connections.

5.8 Transfer of Regular Water Service Connection add

- 5.8.5 On August 23, 2005 the District Board of Directors conducted a public hearing and adopted a resolution that authorized the sale and transfer of the two District owned regular water service connections. The two District owned regular water service connections were included in the original design capacity of the District's water system. The proceeds from the sale and transfer of the two District owned regular water service connections will be deposited into the reserve account for major maintenance, capital improvement.
