1. Call Meeting to Order

4. Public Comment (Non-Agenda Items) Opportunity for the public to speak to the Board on any subject matter within the District’s jurisdiction but not appearing on today’s agenda.
5. President to open the Public Hearing regarding the proposed water rate increases. Speaker times are limited to three (3) minutes per person. Once all public comments are heard, the President will close the public hearing. Board and staff may then have discussions.
6. The Billing Manager, Brenda Kane, will present the calculated number of written protests received on or before 5 PM on the date of this hearing and a tabulation log. The Board Clerk Nancy Veerkamp will review and collect the written protests and file. If a majority protest is counted, the Board cannot approve the rate increase and the matter is concluded. **(Discussion Item)**
7. If no majority protest is counted, the Board may Consider for Approval Resolution 2023-70 approving an increase in the District’s rates for water service. **(Action Item)**
8. Adjourn: The next Regular Meeting is scheduled for August 8, 2023, at 7:00 pm at the Vacaville Fire Protection District, Fire Station #67, 4135 Cantelow Road, Vacaville, CA 95688.
