

RESOLUTION OF THE RURAL NORTH VACAVILLE WATER DISTRICT CONFIRMING DELINQUENT ACCOUNTS FOR UNPAID MONTHLY WATER SERVICE BILLS AND AUTHORIZING THE RECORDING OF REAL PROPERTY LIENS

WHEREAS, on August 27, 1996 the District Board of Directors adopted Resolution No. 02-1996, By-Laws, for the Rural North Vacaville Water District; and

WHEREAS, on August 12, 2002 the District Board of Directors adopted the Operational Rules for the Rural North Vacaville Water District; and

WHEREAS, on September 28, 2004 the District Board of Directors amended the by-laws authorizing the General Manager to process real property liens for unpaid monthly water service bills; and

WHEREAS, on September 28, 2004 the District Board of Directors amended the Operational Rules authorizing the processing of real property liens for unpaid monthly water service bills; and

WHEREAS, Government Code Section 61621 authorizes the District Board of Directors to confirm delinquent accounts and impose liens against the affected real properties for the unpaid amounts; and

WHEREAS, on June 12, 2007 the District Board of Directors conducted a noticed public hearing to consider protests and to adopt a resolution confirming delinquent accounts.

RESOLVED, that the District Board of Directors of the Rural North Vacaville Water District hereby:

1. Adopts the attached delinquency accounts report, which is incorporated herein by this reference.
2. Directs staff to file a certified copy of this resolution with the County Auditor-Controller and to record a certified copy of this resolution with the County Recorder.
3. Directs the General Manager to process documents and have liens recorded with the County Recorder against delinquent real property owners associated with the delinquency accounts report.




