RESOLUTION No. 2009-2

RESOLUTION OF THE BOARD OF DIRECTORS OF THE RURAL NORTH VACAVILLE WATER DISTICT CALLING A GENERAL DISTRICT ELECTION FOR NOVEMBER 3, 2009, TO ELECT TWO DIRECTORS FOR FOUR-YEAR TERMS

WHEREAS, the current terms of Directors James Mortensen and Dieter Teschke of the Board of Directors of the Rural North Vacaville Water District are expiring in December 2009; and

WHEREAS, Election Code section 10509 requires the Secretary of the District to deliver notice to the County Elections Official 125 days prior to the date fixed for the general district election of the intent to conduct an election, including the offices to be filled and whether candidates must pay for the publication of a statement of qualifications in the voter information pamphlet; and

WHEREAS, Election Code section 10522 requires the Secretary of the District to deliver to the Elections Official a map showing the boundaries of the District and a statement indicating that two directors are to be elected at large within the District; and

WHEREAS, it is in the best interests of the District's rate-payers that all candidates seeking to be elected to the Board of Directors shall themselves pay for the publication of a statement of qualifications in the voter information pamphlet, and that the costs of such publication should not be borne by the District; and

WHEREAS, the next available elections date for the District's general election is November 3, 2009.

RESOLVED, the District's next general election is to be conducted on November 3, 2009, for the purpose of electing two directors for four-year terms.

RESOLVED, the District's Secretary shall comply with the duties imposed by statute, described above, delivering notice of the election and a map of the District to the County Election Official, no later than 125 days prior to November 3, 2009.

RESOLVED, the District's Secretary shall request the Elections Official to provide her with copies of each declaration of candidacy filed pursuant to Election Code section 10510.

RESOLVED, except for the duties that the District's Secretary is specifically directed by this Resolution to perform, the Board of Directors requests, pursuant to Elections Code sections 10519 and 10525, that the County Elections Official perform all other duties of the District's Secretary related to the District's general election, including the duties

described in Elections Code sections 10510, 10512, and 10525.

RESOLVED, the District's General Manager is authorized to reimburse the County for the actual costs incurred by the County Elections Official in conducting the general district election for the Rural North Vacaville Water District, and shall promptly pay such reimbursement upon receipt of billing pursuant to Elections Code section 10520.
